The partnership is a program of EPA and the Appalachian Regional Commission (ARC). EPA and ARC have committed up to \$200,000 for technical assistance and implementation in four Appalachian communities. Funds will be used to develop action plans and provide small cash grants for first-step implementation efforts. Learn more on the ARC website.

Interested communities in the <u>ARC-defined Appalachia region</u> should submit a letter of interest, no more than two pages, describing the needs and goals of the community as they pertain to the description above. The selection process will take into account:
